

## **Official Rules**

### **2017 Sauce “Battle For the Dough” Contest**

**THIS CONTEST IS OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES WHO ARE 18 YEARS OF AGE OR OLDER AT TIME OF ENTRY.**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER.**

**Sauce LLC is the “Sponsor” of this contest.**

**1. ASSIGNMENT OF RIGHTS TO UNSUBSCRIBE:** You agree that, by voting in the Contest, you consent to be added into Sauce Pizza & Wine mailing list. Irrecoverably, you may contact Sponsor at any time to unsubscribe or by clicking the unsubscribe link within any Sauce Pizza & Wine email thereafter.

**2. CONDITIONS OF PARTICIPATION:** The contest is open to contestants in Tucson and Phoenix locations. Each participant in these corresponding markets will present a finalized pizza entry on October 2<sup>nd</sup>, 2017. Voting for participating entries in Phoenix to take place between October 2<sup>nd</sup>-18<sup>th</sup> ; voting for participating entries in Tucson to take place between October 2<sup>nd</sup>-23<sup>rd</sup>. The winner of the Phoenix contest will be announced on October 19, 2017; the winner of the Tucson contest will be announced on October 24, 2017. Winning entries will be promoted in-store and will be a featured pizza between November 1<sup>st</sup>-22<sup>nd</sup>, 2017. Sponsor is not responsible in the event that the participant provides any incorrect, expired, or otherwise invalid information. The Sponsor shall have the right to disqualify any Entries that do not comply with the Official Rules, as determined by Sponsor in its sole discretion. The potential winner must agree to a criminal background check and may be disqualified if the background check reveals anything that could bring Sponsor into disrepute due to winner’s association with Sponsor, as determined by Sponsor in its sole discretion.
